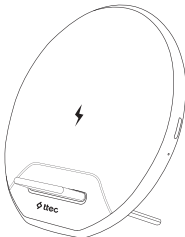

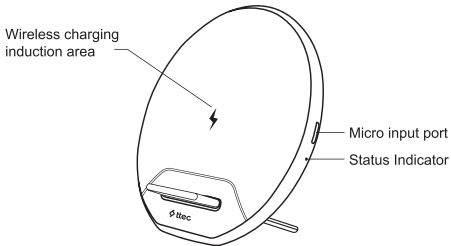

## Notes

- Keep the product away from magnetic stripe cards and chip cards (ID, credit card etc.) in order to avoid magnetic malfunctions.
- Do not place a metal object or an object with a metal casing on the wireless charging dock - Avoid strong impacts.
- This is a highly sensitive electronic product. Please do not attempt to disassemble the product and do not tamper with it.
- Do not use the product under high temperatures, low air pressure, in humid or extremely dusty environments, in direct sunlight for an extended period of time and in intense magnetic fields.
- We recommend you use the product in an environment where the altitude is below 3000 meters, the temperature is between 0°C and 35°C, and humidity is between 5% and 95%. - Do not expose the product to water or to a water splash.
- Keep product accessories away from objects such as a glass full of liquids.
- In order to prevent possible interactions, maintain a distance of at least 20 cm between an implanted medical device (pacemakers, cochlear implants etc.) and the wireless charging dock.
- When charging the product, only use chargers that are in line with the instructions in this user manual.
- Using chargers that are not in line with these instructions can be dangerous.
- Dispose of these products and accessories in accordance with your local environmental regulations.
